## IMPORTANT:

---

1. This result is provisional and is being declared on the basis of the information furnished by the candidates in their Online Registration Forms, who were provisionally permitted to appear in the Computer Based Test (CBT) Recruitment Examination without prior screening of their Online Registration Forms. Their candidature is subject to fulfilment of all eligibility conditions prescribed in the Advertisement/Prospectus and subsequent Corrigendum(s)/ Addendum(s), as published on the website.
2. The appointment of provisionally selected candidates shall be strictly subject to verification of all original certificates/documents and fulfilment of the prescribed medical fitness requirements. The shortlisted candidates shall undergo medical examination as per the standards prescribed by KPL. Candidates who do not meet the prescribed medical fitness criteria shall not be considered for appointment.
3. Inclusion of a candidate's name in the result does not confer any right to appointment. The candidature and selection shall remain subject to completion of the prescribed verification and other applicable processes.
4. Reporting, Document Verification and further evaluation of eligibility criteria shall be conducted by Kamarajar Port Limited in a time-bound manner, as per the decision of the Competent Authority.
5. Biometric data and photographs captured during registration/examination shall be subject to verification at appropriate stages. Any discrepancy noticed during such verification may invite further scrutiny and, where found to affect the identity or eligibility of the candidate, appropriate action may be taken, including cancellation of candidature or withdrawal/modification of the result or offer letter, if already issued.
6. The candidature and result shall remain subject to verification of relevant examination and candidature records, including system-generated records and other records maintained in connection with the examination. Any discrepancy, inconsistency or material information coming to notice subsequently may be examined by the Competent Authority and appropriate action may be taken in accordance with the applicable rules.
7. Candidates who fail to produce valid OBC/EWS/SC/ST/PwBD category certificates or any other requisite certificates/documents as prescribed under the eligibility criteria, during Document Verification or whenever required to produce the same, shall be liable for cancellation of their candidature.
8. Candidates are advised to carefully verify their eligibility, including eligibility under the applicable category (including PwBD), for the post before reporting for further stages of the recruitment process. If a candidate is found ineligible at any stage on account of age, qualification, experience, category certificate or any other prescribed condition, the candidature shall be liable to cancellation, even if the candidate has been allocated a seat. In such cases, the selection shall be treated as void ab initio.

9. Any PwBD candidate to whom a seat is allocated shall be examined by a Medical Board constituted by Kamarajar Port Limited (KPL), and appointment shall be subject to clearance by the said Medical Board.
10. Any inadvertent error, omission or discrepancy in the result or related records, if noticed subsequently, may be rectified by the Competent Authority in accordance with the applicable rules. The decision of KPL shall be final and binding.
